As the Associate Director of Treatment and Recovery Services you will be planning, coordinating, and directing the substance abuse and mental health treatment and recovery services of the Office of Substance Abuse and Mental Health Services (SAMHS) on a statewide basis. You will be responsible for program planning, policy development and implementation; oversee the substance abuse workforce development plan, program evaluation and management. You will provide supervision of the day-to-day operation of the mental health treatment and recovery services of SAMHS Office. Duties also include supervising multiple program areas and staff,

developing/presenting/discussing/interpreting agency policy, procedures, standards and expectations. You will also review, analyze, and monitor program data and related programmatic issues and you will represent the Office at local, state, regional, and national meetings.

Requirements: A minimal requirement of a Bachelors Degree in the mental health, social sciences, behavioral health, health, education or related field and at least six (6) years of professional experience and responsibility in substance abuse and/or mental health (both preferred), to include at least three (3) years at the program management/administrative level within the related field.
