### **Capitol Hill Happenings**



#### House hearing on 21st Century Cures Implementation: Examining Mental Health Initiatives

Last week the House Energy & Commerce Committee's Subcommittee on Health, led by Chairman Michael Burgess (R-TX) and Ranking Member Gene Green (D-TX), held a hearing entitled, "21st Century Cures Implementation: Examining Mental Health Initiatives." Assistant Secretary of Mental Health and Substance Use, Dr. Elinore McCance-Katz, served as a witness during the hearing.

In her testimony and in response to questions from members of the subcommittee, the Assistant Secretary highlighted how the Substance Abuse and Mental Health Services Administration is implementing the 21st Century Cures Act provisions, and how implementation is benefiting individuals, families, and communities across the country.

While the intent of the hearing was to hear an update from SAMHSA specifically on implementation of Cures, many members of the subcommittee used their time to ask Dr. McCance-Katz about mental health

House subcommittee holds hearing on marketing practices in the substance use treatment industry

On July 24th, the House of Representatives Subcommittee on Oversight and Investigations, led by Chairman Gregg Harper (R-MS) and Ranking Member Diana DeGette (D-CO), held a hearing on practices within the substance use treatment industry, including advertising and marketing practices. This hearing was part of the Subcommittee's ongoing efforts to address unethical practices in the treatment field such as patient brokering.

#### In the News

#### Recent study finds 65% increase in cirrhosis from 1999-2016 in the U.S.

A <u>new paper</u> published in *The BMJ* found that from 1999 to 2016 in the U.S., annual deaths from cirrhosis increased by 65 percent. Researchers used death certificate data from the Vital Statistics Cooperative, and population data from the US Census Bureau compiled by the Center for Disease Control and Prevention's (CDC) Wide-ranging Online Data for Epidemiologic Research (1999-2016). They found that mortality due to cirrhosis has been increasing in the U.S. since 2009, driven by deaths due to alcoholic cirrhosis. Individuals aged 25-34 have experienced the greatest relative increase in mortality. Caucasians, Native Americans, and Hispanic Americans experienced the greatest increase in deaths from cirrhosis. Researchers conclude that the rapid increase in death rates among young people due to alcohol highlight new challenges for care of patients with preventable liver disease.

#### NIDA offering online course on adolescent marijuana use

The National Institute on Drug Abuse (NIDA), in collaboration with the Institute for Research, Education, and Training in Addictions (IRETA), is offering a self-paced <u>online course</u> on the assessment and treatment of adolescent marijuana abuse and dependence. The course focuses on the risks for marijuana use in adolescents, newly developed tools for screening youths for marijuana dependence, and resources for treating adolescents with cannabis use disorder. The course also covers topics such as driving and marijuana use and aftercare programs for preventing relapse.
