Featured Keynote: Tom Coderre

The Acting Assistant Secretary for Mental Health and Substance Use will share SAMHSA's priorities, policies, initiatives, and resources for the field.

With decades of public, private, and non-profit service, Acting Assistant Secretary Coderre is the first person in recovery to lead the Substance Abuse and Mental Health Services Administration (SAMHSA). His career has been significantly influenced by his personal journey and a philosophy that acknowledges the essential role peer recovery support services play in helping people with mental and substance use disorders rebuild their lives. Mr. Coderre is a career civil servant who is on detail from his position as SAMHSA's Regional Administrator for New England.

Mr. Coderre was Senior Advisor to former Rhode Island Governor Gina Raimondo, where he helped coordinate the state's response to the opioid crisis. Prior to that, he served as senior advisor and then chief of staff at SAMHSA as an appointee of President Obama. Mr. Coderre worked to advance federal mental health and addiction policies and led the team that produced "Facing Addiction in America: The Surgeon General's Report on Alcohol, Drugs, and Health," the first report from a U.S. Surgeon General about the public health crisis.
