Senate Committee Hearing on Youth Mental Health
On February 15th, the Senate Committee on Finance hosted their second hearing on the youth mental health crisis. This hearing, led by Senator Ron Wyden (D-OR) and Senator Mike Crapo (R-ID), specifically examined strategies for eliminating barriers to care. The discussion focused heavily on policy levers for strengthening and increasing mental health services to schools, specialty populations, and rural populations. Subcommittee on Oversight and Investigations Hearing on Mental Health Crisis

CDC's Draft Clinical Practice Guideline for Prescribing Opioids Now Open for **Public Comment**

The Centers for Disease Control and Prevention (CDC) draft Proposed 2022 CDC Clinical Practice Guideline for Prescribing Opioids is postedin the Federal Register for public comment until April 11, 2022. The clinical guidance is an update to the 2016 Guideline for Prescribing Opioids for Chronic Pain. CDC offers specific instructions for updating the guidance, available here.

FDA Administrator Confirmed

On February 15, the Senate confirmed Dr. Robert Califf to lead the Food and Drug Administration (FDA). Previously, Dr. Califf served as the FDA's Deputy Commissioner for Medical Products and Tobacco from February 2015 until his appointment as Commissioner in February 2016. Prior to joining the FDA, Dr. Califf was a professor of medicine and vice chancellor for clinical and translational research at Duke University.



NIH: Analysis of Death Records Shows Growing Disparities in Opioid Epidemic

A National Institutes of Health (NIH) funded study examined drug overdose death trends through death certificate data over the last decade and found an increase in racial disparities among overdose deaths and an increase in stimulant use. The study found that opioid/stimulant deaths among Black Americans have risen at more than three times the rate seen among non-Hispanic white people, especially in eastern States. In other parts of the country, there's also been a disproportionate increase in combination overdose deaths among Hispanic and Asian Americans.

BJA: Managing Substance Withdrawal in Jails

The Department of Justice (DOJ) Bureau of Justice Assistance (BJA) released a <u>legal brief</u> on considerations for



implementing withdrawal policy and protocols that will ensure legal compliance for individuals in jails. The brief further discusses the scope of the challenge, overview of constitutional rights, and key legislation related to substance use withdrawal, and outlines steps for creating a comprehensive response to substance use disorders (SUD).

NIJ: Five Things About Substance Use Interventions

The National Institute of Justice (NIJ) released <u>five practices</u> to <u>understand about substance use</u> as rated by crime solutions. These included practice profiles for:

- 1) Medication-assisted treatment (MAT) for reducing opioid dependence;
- 2) Cannabis use disorder treatment using psychosocial interventions;
- 3) Strategies that reward positive behavior and withhold rewards when undesired behavior is exhibited can reduce alcohol, tobacco, and illicit drug use;
- 4) Short-term interventions to reduce alcohol use or related problems for adolescents and young adults;
- 5) Juvenile drug courts effects on drug and alcohol offense recidivism or future drug use.

APIS Releases New COVID-19 State Alcohol Policy Dataset

The Alcohol Policy Information System (APIS), a project of the National Institute on Alcohol Abuse and Alcoholism (NIAAA), announced the release of updated resources on alcohol-related policies adopted in response to the COVID-19 pandemic. As described in the <u>press release</u>, APIS provides an updated Dataset and Codebook to represent state-level policies affecting alcohol availability during the COVID-19 emergency in a form that facilitates incorporating



these policies in statistical and other analyses. The new Dataset, presented as an Excel file with a Codebook that provides definitions for the variables, complements the coverage in the Digest of State Alcohol-Related Laws During the COVID-19 Emergency for On-Premises and Off-Premises Establishments.
