SAMHSA accepting applications for Director of CSAP

The Substance Abuse and Mental Health Services Administration (SAMHSA) released a job announcement for the position of Director of the Center for Substance Abuse Prevention (CSAP). As described in the posting, the Director of CSAP plans, develops, implements, and reviews disease prevention and health promotion policies related to alcohol and other drug use, and analyzes the impact of Federal activities on State and local government and private program activities. In addition, the Director provides leadership in establishing and maintaining liaisons with other agencies and organizations and serves as the principal advisor on all CSAP policy and program activities. SAMHSA releases PSA flyers for parents and caregivers

Administration (SAMHSA) recently expanded their <u>Talk. They Hear You</u> substance use prevention campaign. The purpose of the campaign is to help parents and caregivers start talking to their children early about the dangers of alcohol and other drugs. In addition to an app, public service announcement

(PSA) videos, and guides, the campaign has now introduced <u>PSA flyers</u>. Each PSA flyer encourages parents to talk to their children at different times throughout the day. For example, there are flyers for talking to children before dropping them off at a party, before getting behind the wheel, and on the way to sports practice.

Research Roundup

NIDA study finds increases in methamphetamine overdose deaths

A <u>study</u> from the National Institute on Drug Abuse (NIDA) found that overdose deaths involving methamphetamine nearly tripled from 2015 to 2019. As described in a <u>press release</u>, researchers analyzed data from the National Vital Statistics System and the National Survey on Drug Use and Health (NSDUH) and found that the number of overdose deaths involving psychostimulant drugs other than cocaine rose from 5,526 to 15,489, a 180% increase. However, the number of people who reported using methamphetamine only increased by 43% over the same period. Researchers noted that the discrepancy between overdose deaths and reports of use could be a result of increases in methamphetamine use disorder, frequent use, and polysubstance use. Finally, researchers also found that

American Indians/Alaska Natives had the highest prevalence of methamphetamine use which contrasts with historical trends of use concentrated in middle-aged white persons.


Study examines polysubstance use among patients treated with buprenorphine

A recently published <u>study</u> examined polysubstance use among patients treated with buprenorphine. Over 150,000 urine drug tests were examined from a national database and nearly half of all patients prescribed buprenorphine also tested positive for at least one nonprescribed substance. However, when compared with patients whose specimens were not positive for buprenorphine, those with positive specimens had significantly lower odds of testing positive for nonprescribed substances, with the strongest associations for fentanyl and heroin.

In the News

CoE-PHI releases resource on 42 CFR Part 2

The Center of Excellence for Protected Health Information (CoE-PHI) released their first resource to help healthcare professionals and administrators who provide substance use disorder (SUD) services to determine if 42 CFR Part 2 applies to them or their practice. The resource includes a decision tree called "I Provide SUD Services in an FQHC: Does Part 2 Apply to Me?" and provides definitions for key terms used in the decision tree. CoE-PHI also



announced that their second eLearning module, "Does Part 2 Apply to Me or My Practice?", will be released in the near future.
