Capitol Hill Happenings

House Passes Defense Bill with Provisions to Respond to the Opioid Crisis

The House of Representatives passed the National Defense Authorization Act (NDAA) for Fiscal Year 2023 (H.R. 7900) on July 14th, which authorizes \$840 billion in defense spending for FY23 to bolster the development of new technology, coordination with America's network of allies and partners, and support for service members and their families. The NDAA also contains priorities related to combating the opioid crisis, including Representative David Trone's (D-MD-6) Fighting Emerging Narcotics Through Additional Nations to Yield Lasting (FENTANYL) Results Act. The FENTANYL Act would authorize the State Department to develop programs to assist foreign law enforcement efforts to identify synthetic drug trafficking and establish an exchange program for international drug demand reduction experts.

Around the Agencies

CDC Foundation Advances Overdose Response Strategy Nationwide

The Centers for Disease Control and Prevention (CDC)
Foundation recently launched the Overdose Response Strategy (ORS), an initiative that aims to help local communities from all 50 States, Puerto Rico, and U.S. Virgin Islands reduce drug overdoses by sharing timely data and innovative, evidence-based strategies. The CDC Foundation assists the ORS by building capacity and fully staffing the program with support from 33 High Intensity Drug Trafficking Areas (HIDTA), as well as developing multisector partnerships, jurisdictional strategic plans, and providing technical assistance, training, and overall programmatic implementation and evaluation for the public health portion. The ORS is funded by CDC's National Center for Injury Prevention and Control (NCIPC) and the Office of National Drug Control Policy (ONDCP), and supported the recent hiring of 60 public health analysts to partner with public health and safety offices nationwide.

HHS Renews COVID-19 Public Health Emergency Declaration

The Department of Health and Human Services' (HHS) Secretary, Xavier Becerra, renewed the COVID-19 public health emergency declaration, effective July 15th. The declaration gives health care providers and State and Territorial health departments continued flexibility to respond to the pandemic, such as rapid patient care within emergencies, including waivers from the Centers for Medicare and Medicaid Services (CMS) for some requirements under section 1135 of the Social Security Act. The first U.S. COVID-19 public health emergency declaration was signed in January 2020 and has been renewed every 90 days per law. HHS will provide no less than 60 days' notice

before the termination of the declaration.

NCSACW Announces Virtual 2023 Policy Academy



The National Center on Substance Abuse and Child Welfare (NCSACW) announced the 2023 Policy Academy: Advancing Collaborative Practice and Policy: Promoting Healthy Development and Family Recovery for Infants, Children, Parents, and Caregivers Affected by Prenatal Substance Exposure. The Academy will meet virtually over six months, beginning in September 2022, with pre-and post-event activities and a virtual event session on January 24-26, 2023. The Policy Academy aims to help States, Tribes, and large counties enhance cooperation to support infants affected by prenatal substance exposure, their parents, and caregivers. Teams will make action plans to develop strategies to boost collaboration, improve outcomes for affected families, and mitigate systemic bias and stigma toward people with substance use and mental disorders.

Participation in the Policy Academy includes:

- "An orientation webinar Wednesday, October 19, 2022, at 11:00 AM PT/ 2:00 PM ET
- Policy Academy pre-event technical assistance from a designated NCSACW Change Liaison and three plenary webinars from national subject matter experts
- Facilitated team time, expert consultation, and peer-networking opportunities at the three-day Policy Academy virtual session convening
- Policy Academy post-convening event technical assistance to support implementation of the action plan developed during the conference"

NCSACW invites joint applications from the state child welfare agency, the State substance use treatment agency, the Administrative Office of the Courts overseeing dependency courts, Tribes or tribal consortiums, State public health agencies, and counties with a population over 2 million. There is no fee to participate in the Policy Academy. Applications are due on August 24, 2022, at 5:00 pm PT. Application instructions and more information on the Academy can be found here.

State Spotlight

Governor DeWine Announces First Local Government Payments from National Opioid Settlement

Ohio Governor Mike DeWine <u>announced</u> that the first payments of the more than \$8.6 million of funds from the OneOhio settlement with national opioid distributors were made electronically on July 15th to local governments. Local governments will determine how to best use the payments to combat the opioid epidemic in their communities and will continue to receive payments for the next 18 years. The funds must be applied according to the approved Ohio Abatement Strategies of Exhibit A of the <u>OneOhio Memorandum of Understanding</u>. Additional funding for the benefit of all communities in Ohio will also be available through the <u>OneOhio Recovery Foundation</u>.

A full list of payments made to eligible and participating political subdivisions can be found <u>here</u>. The list also indicates if the payments were made directly to the entity or, if less than \$500, were redirected to the county.

988 Suicide and Crisis Lifeline Volunteer and Job Opportunities

In May, the Substance Abuse and Mental Health Services Administration (SAMHSA) created a <u>webpage</u> that links prospective applicants to 988 crisis center hiring or volunteer pages. The 988



network is looking to bring on new volunteers and paid employees to answer calls, chats, and texts from people in crisis. All employees and volunteers will receive training on how to respond to someone who may be experiencing a mental health, substance use, or suicidal crisis.
