Capitol Hill Happenings

House Appropriations Committee Markup on FY 2023 Transportation, and Housing and Urban Development, and Related Agencies Appropriations

Bills

The House Appropriations Committee held a markup on June 30, 2022, on the Fiscal Year 2023 Transportation, and Housing and Urban Development, and Related Agencies; Labor, Health and Human Services, Education, and Related Agencies Appropriations Bills and Revised Report on the Subcommittee Allocations. The bill provides \$242.1 billion in funding for the Departments of Health and Human Services (HHS), Department of Labor (DOL), and Department of Education (DOE) with funding for several NASADAD priority programs. Around the Agencies

DEA Inaugural Family Summit on the Overdose Epidemic

The Drug Enforcement Administration (DEA) held the first-ever <u>DEA Family Summit on the Overdose Epidemic</u> on June 14 and 15 for families who lost a child from a drug overdose. The Family Summit aims to reverse the overdose epidemic by bringing together partners, families, and community groups working to decrease overdose deaths to raise awareness of the severe drug threats facing U.S. communities. The families and DEA were joined by the Department of Justice (DOJ), Centers for Disease Control and Prevention (CDC), Substance Abuse and Mental Health Services Administration (SAMHSA), Department of Education (DOE), and Partnership to End Addiction to discuss the scope of current drug threats, how they can further amplify community prevention efforts, and areas for collaboration. In addition, the Summit offered various opportunities for families to share their stories, engage in discussion, and explore awareness and prevention resources offered by DEA.

GAO: Preliminary Observations on the 2022 National Drug Control Strategy

ACCOUNTABILITY OFFICE The Government Accountability Office (GAO) recently released their Preliminary Observations on the Office of National Drug Control Policy's (ONDCP) 2022 National Drug Control Strategy. Federal efforts to prevent, respond, and recover from drug misuse made GAO's 2021 High-Risk Update, which notes the Strategy's centrality in reducing drug overdose deaths. GAO reports that federal drug control efforts aim to reduce illegal drug supply and demand by promoting prevention, early intervention, treatment, and recovery services, as well as interdiction, international operations, and law enforcement efforts. The preliminary review found that ONDCP had annual quantifiable and measurable objectives and specific targets for quantifiable longterm goals but was unable to discern if they addressed statutorily required information on performance evaluation planning, estimates of resources needed for its goals, and a systematic plan for increasing data collection. This is, in part, because the Strategy refers to this information in documents that are not yet available. ONDCP may conclude this information in accompanying National Drug Control Strategy documents it plans to release later this year.

HRSA Releases Area Health Resources Files Diversity Dashboard

The Health Resources and Services Administration's (HRSA) National Center for Health Workforce Analysis (NCHWA) recently released the Area Health Resources Files (AHRF) Diversity Dashboard, sentialing undated data on the diversity of the U.S. health workforce. The dashboard

The dashboard allows users to interact with detailed demographic information from the county, State, and national levels for nearly 40 healthcare occupations. AHRF provides data on health care professions, health facilities, population characteristics, economics, health professions training, hospital utilization, hospital expenditures, and environment. HHS Releases Guidance on Audio-Only Telehealth Services Under HIPAA Privacy Rules

The Department of Health and Human Services (HHS) recently released guidance on how health care providers and health plans can deliver audio-only telehealth services consistent with the Health Insurance Portability and Accountability Act of 1998's (HIPAA) privacy requirements. Audio telehealth has become vital since the COVID-19 pandemic, especially for



patients in rural communities, individuals with disabilities, and those seeking convenient remote options who are unable to access physical medical services or communication technologies used for audio-video telehealth. The official guidance and FAQs can be found here.

CDC Releases New Training and Resources to Promote the Importance of Naloxone

The Centers for Disease Control and Prevention (CDC) recently released a <u>suite of training and resources</u> promoting the importance of naloxone as a critical component for combating the opioid overdose epidemic. The suite aims to mitigate the risks associated with opioid overdose, increase naloxone

dispensing across the U.S., and reduce the stigma surrounding naloxone in clinical settings. Naloxone training is offered as a full module or as separate mini-modules and patient cases. Clinicians are eligible to earn continuing education (CE) credits after completing the full module.
