

SAMHSA Releases Resources for Pride Month

The Substance Abuse and Mental Health Services

Administration (SAMHSA) is recognizing June as Pride Month
by highlighting their webpage on Lesbian, Gay, Bisexual, Transgender, Queer, and
Intersex (LGBTQI+). This webpage includes national survey reports, agency and federal initiatives, and other resources for supporting LGBTQI+ individuals.

SAMHSA Awards Grants to Build Out Crisis Response Services

Last week, the Department of Health and Human Services (HHS), through the Substance Abuse and Mental Health Services Administration (SAMHSA) <u>awarded 13 grants</u> to communities to foster new and improve existing mobile crisis response teams. According to the press release, "the awarded teams will respond to mental health and substance



use crises in high-need areas, in coordination with local law enforcement."

Awardees are required to strengthen crisis system capacity by "...providing post-crisis follow-up, developing and implementing protocols for coordination with law enforcement, providing evidence-based crisis training to providers and first responders, mapping community crisis systems, and improving the use of data." These efforts aim to establish timely access to trained mental health professionals for individuals in crisis and to help ease the burden on law enforcement. DEA National Take Back Day Results for April 2023

DEA NATIONAL B The Drug Enforcement Administration (DEA) released the results from the 24th National Take Back Day from April, 2023. The agency saw 4,497 Law Enforcement Agencies participating across 4,955 total collection sites. At these sites, a total of 663,725 pounds of prescription medication was collected, bringing the all-time total collected to 17,300,454 pounds. Applications Now Open: STAR Loan Repayment Program

The Health Resources and Services Administration (HRSA) announced funding for the Substance Use Disorder Treatment and Recovery Loan Repayment Program (STAR-LRP). The program offers up to \$250,000 in educational loan repayment in exchange for awardees agreeing to work full-time for six years in a STAR LRP-approved facility. Applicants must be a United States citizen, fully licensed, credentialed in an eligible discipline, or a registered SUD professional, and a full-time employee at a STAR LRPapproved facility. The Health Resources and Services Administration (HRSA) recently announced an \$8.4 million funding opportunity for the Behavioral Health Workforce Education and Training-Children, Adolescents, and Transitional Aged Youth (BHWET-CAY) Program for Professionals. The program aims to "...address the behavioral health needs of children, adolescents, and transitional-aged youth by increasing the supply and distribution of behavioral health providers in rural and underserved communities." HRSA will offer up to 16 awards. Applications are due June 1st.
