# NASADAD Attends White House Event Where President Biden Announces Proposed Rule Seeking to Strengthen Parity Implementation

On Tuesday, July 25, NASADAD Executive Director Robert Morrison attended an event held at the White House where President Biden announced the release of a Proposed Rule



that seeks to strengthen certain aspects of the Mental Health Parity Addiction Equity Act (MHPAEA). The event included remarks by Senator Debbie Stabenow (D-MI) and Richele Keas, a mental health advocate with experience navigating health insurance for her daughter. The event hosted many leaders in the substance use disorder and mental health field, including Dr. Vivek Murthy, U.S. Surgeon General; former Rep. Patrick Kennedy; Dr. Miriam Delphin-Rittmon, Assistant Secretary, Substance Abuse and Mental Health Services Administration (SAMHSA); Julie Sue, Acting Secretary of Labor; Marty Walsh, former Secretary of Labor; Rep. Paul Tonko (D-N.Y.); Rep. Debbie Dingell (D-MI); Rep. Grace Napolitano (D-CA); Rep. Mark Takano (D-CA); and many others.

**Key components of the announcement:** The Proposed Rule seeks the following:

- Under the Proposed Rule, health plans would be required to evaluate the findings of comparative analyses that were mandated by Congress in changes to MHPAEA in 2020. The 2020 changes required health plans to conduct comparative analyses with an eye on ensuring that access to mental health and substance use benefits were on par with physical health care. In requiring health plans to evaluate the outcomes of the analyses, the Proposed Rule envisions a deeper examination to assess the adequacy of the plan's provider network, the payment rate to out-of-network providers, and the extent to which prior authorization is mandatory and the extent to which prior authorizations are denied. This information, according to the Biden information Fact Sheets, would then illustrate where plans are failing to meet the requirements of MHPAEA and jumpstart improvements according to the law.
- The Proposed Rule would provide more specific examples to help illustrate to health plans and others approaches that are unlawful under MHPAEA. These examples would include overly restrictive prior authorization processes and medical management techniques that are not on par with medical benefits. According to the White House Fact Sheet, health plans would be required to "...use similar factors in setting out-of-network payment rates for mental health and substance use disorder providers as they do for medical providers."
- The Proposed Rule would seek to extend the requirements of MHPAEA to health plans that have not been included to date. The White House Fact sheet notes examples include health plans offered to State and local government employees.

#### Additional Request for Information forthcoming:

The Administration, according to the Fact Sheet, noted that it would "...issue a
request for information on how it can best work with states to ensure compliance
with MHPAEA's critical protections for the millions of Medicaid beneficiaries
enrolled in private Medicaid health plans." NASADAD will seek to forward this
request for information when it is released.



### **Capitol Hill Happenings**

### Senate Appropriations Approves Proposed FY 2024 Spending Bill – Includes \$40 million Increase for SUPTRS Block Grant

On Thursday, July 27, the Senate Appropriations Committee considered and passed an FY 2024 funding bill for NASADAD priority programs including the Substance Abuse and Mental Health Services



Administration (SAMHSA), Centers for Disease

Control and Prevention (CDC), Health Resources and Services Administration (HRSA) and others within the Department of Health and Human Services (HHS). The panel approved the \$224.4 billion measure by a vote of 25 to 1. NASADAD will be working on a full chart outlining proprosed FY 2024 spending for the many proposed programs within HHS. As this work moves forward, we are first including key updates below:

Substance /use Prevention, Treatment, Recovery Services (SUPTRS) Block Grant: \$2,048,079,000.00 or an increase of \$40 million compared to FY 2023, according to the Press Release.

**Center for Substance Abuse Prevention:** \$236,879,000.00 or level funding compared to FY 2023

**State Opioid Response (SOR):** \$1,595,000,000.00 or an increase of \$70 million compared to FY 2023

#### Oversight Hearing on the Office of National Drug Control Policy

Yesterday, the House Oversight and Accountability Committee held a hearing on "Oversight and Reauthorization of the Office of National Drug Control Policy." Dr. Rahul Gupta, Director, Office of National Drug Control Policy (ONDCP) testified regarding the critical services and initiatives delivered by ONDCP. Dr. Gupta discussed the magnitude of drug overdose deaths over the last few years and the current challenges - such as naloxone availability, affordability, and accessibility - to address drug overdoses. Dr. Gupta outlined past and current efforts to secure the border and support law enforcement; commercial disruption; and the overall public health response and efforts.

ONDCP was last reauthorized in October 2018 through the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities Act (SUPPORT Act) and expires on September 30, 2023.

## CDC Announces National Search to Hire a New Director for CDC's Injury Prevention and Control Center

The Centers for Disease Control and Prevention (CDC) recently announced a national search to hire a director for the <a href="CDC's">CDC's</a> <a href="National Center for Injury Prevention and Control">National Center for Injury Prevention and Control</a> (Injury Center).



This role was held by CAPT Christopher Jones, PharmD, DrPH, MPH, who will be joining the Substance Abuse and Mental Health Services (SAMHSA) as Director of the Center for Substance Abuse Prevention (CSAP) on August 21, 2023.

The CDC's Injury Center has been a leader in protecting Americans from injury and violence so that individuals, families, and communities can be safe, healthy, and thriving. The new director will continue to lead this work and "...oversee a national program for non-occupational injury prevention and control with federal, state, and local agencies and communities."

In this position, the director will:

 "Provide leadership in developing and executing a national program for nonoccupational injury prevention and control with federal, state and local agencies,

- voluntary and private sector organizations
- Participate as a member of CDC's Senior Leadership team and as such be engaged in long term strategic decisions that impact the effectiveness and efficiency of the Agency
- Provide the vision and direction to accomplish CDC's strategic imperatives and goals management program as they relate to injury prevention and control and Center priorities related to adverse childhood experiences, overdose, and suicide prevention
- Lead and manage the performance of the organization to align with and attain agency goals and organizational objectives and advances the state of science through research and development intramurally and extramurally and continuously improves public health programs through innovation, program development, and rigorous performance management and evaluation, and
- Strategically manage the Center's human capital and recruiting and retaining the best scientists, program managers, and other disciplines while always maintaining the utmost scientific and ethical integrity personally and organizationally."

Applications are due August 18, 2023, at <u>RF-601 (PhDs and equivalent)</u> and <u>RF-602 (MDs only)</u>.

## CDC Study Finds Cannabis-Involved ED Visits Among You Persons Increased During COVID

A recent <u>study</u> published by the Centers for Disease Control and Prevention (CDC) in the Morbidity and Mortality Weekly Report (MMWR) found that cannabis-involved emergency department (ED) visits were higher during the COVID-19 pandemic than during 2019. The report found "Large increases in cannabis-involved ED visit rates occurred among children aged ≤10 years, and among persons aged 11-14 years" and that "…rates among females aged 11-14 years increased more than they did among males." The specific reasons driving these increases are unknown and may differ by age group. Further, the CDC reports that the number of visits has continued to remain elevated above 2019 levels post-pandemic. These findings emphasize the importance of implementing evidence-based youth substance use prevention interventions in communities and schools to address changing patterns of cannabis use during the pandemic.
