## **Capitol Hill Happenings**

## SUPPORT Act Mark-Up in the Senate

This week, Chairman Senator Bernie Sanders (I-VT) and Ranking Member Senator Bill Cassidy (R-LA) of the Senate Committee on Health, Education, Labor and Pensions(HELP) introduced legislation to reauthorize the SUPPORT Act. The SUPPORT for Patients and Communities Reauthorization Act (S.3393) will reauthorize programs such as SAMHSA's Pregnant and Post Partum Women's (PPW) Residential and Pilot Program, First Responder Training Program, and HRSA's Loan Repayment Program for SUD, among others. The bill also includes a section (109) that "Clarifies that State Opioid Response grant program funds may be used for products that may prevent overdose by detecting one or more substances, such as test strips, to the extent such products are permitted under Federal and State law."

#### Senate Indian Affairs Committee Hearing on "Fentanyl in Native Communities: Examining the Federal Response to the Growing Crisis"

Yesterday, the Senate Indian Affairs Committee conducted a full committee hearing on *Fentanyl in Native Communities: Examining the Federal Response to the Growing Crisis*. This oversight hearing was designed to provide federal substance use agencies the opportunity to share their perspectives on the fentanyl crisis in Native communities. Witnesses discussed their agencies' efforts to address fentanyl in Native communities, trends in fentanyl use in Native communities, and population-specific needs to target to respond to the ongoing crisis. Witnesses included:

## New SAMHSA Resources on Efforts to Identify and Address Challenges Affecting Buprenorphine Access in Pharmacies



The Substance Abuse and Mental Health Services Administration (SAMHSA), in collaboration with federal partners, recently released two reports on <u>Efforts to Identify</u> and Address Challenges Affecting Buprenorphine Access in Pharmacies. These new reports are based on conversations SAMHSA had with the Drug Enforcement Administration (DEA), the Department of Health and Human Services' (HHS) Office of the Assistant Secretary for Health (OASH), pharmacies, and State health departments. The reports' release comes as expanding access to buprenorphine has been made a top priority of the <u>HHS Overdose Prevention Strategy</u>. The two new reports include:

- <u>Policy Priority Roundtable Summary Report</u>: "In August 2022, SAMHSA convened a Policy Priority Roundtable with pharmacy organizations, state health departments, nonprofit associations, academic institutions, and people with lived experiences. where pharmacy organizations called for an opportunity to engage directly with federal agencies about challenges affecting buprenorphine supply."
- <u>Virtual Town Hall Report</u>: SAMHSA joined other federal partners to jointly host a town hall where participants, including pharmacy organizations involved in buprenorphine distribution, discussed challenges and solutions to increase access to this life-saving medication."

# HHS Releases Social Media Toolkit on 2023 Medicaid and CHIP Renewals

The Department of Health and Human Services (HHS) recently released a social media toolkit on 2023 Medicaid and CHIP Renewals. The toolkit includes suggested language and graphics to highlight various HHS and Centers for Medicare and Medicaid Services (CMS) resources for specific populations, demographic groups, and entities involved in Medicaid and CHIP renewals. In addition to group-specific fact sheets, the toolkit includes CMS' Partner Call to Action to keep people covered as Medicaid renewals restart. Aside from the communications input, the social media toolkit provides links to slide decks, webinars, and research to train organizations on how to help people learn about Medicaid and CHIP renewals.

# CDC Report Examines the Impact of Cigarette Smoking Cessation Behaviors on Tobacco-Related **Disease and Death**

The Centers for Disease Control and Prevention (CDC), in collaboration with the National Cancer Institute (NCI) and the Food and Drug Administration (FDA), published an article in Preventing Chronic Disease on State-Specific Prevalence of Adult Tobacco Product Use and Cigarette Smoking Cessation Behaviors, United States, 2018-2019. Self-reported data from the 2018-2019 Tobacco Use Supplement to the <u>Current Population Survey (TUS-CPS)</u> of American adults across the country was

examined to determine State-specific prevalence of tobacco use, interest and attempts to quit smoking, and the use of cigarette smoking cessation behaviors and their impact on tobacco-related disease and death. Key findings include:

- "Prevalence of current any-tobacco use (use every day or some days) ranged from 10.2% in California to 29.0% in West Virginia.
- Percentage of adults who:
  - currently smoked cigarettes and were interested in quitting ranged from 68.2% in Alabama to 87.5% in Connecticut;
  - made a past-year quit attempt ranged from 44.1% in Tennessee to 62.8% in Rhode Island;
  - reported recent successful cessation ranged from 4.6% in West Virginia and Wisconsin to 10.8% in South Dakota; and
  - used medications and/or counseling to quit ranged from 25.5% in Nevada to 50.1% in Massachusetts."

Several states with the highest cigarette smoking prevalence reported lower prevalence of interest in quitting, quit attempts, use of counseling or medication, and higher prevalence of e-cigarette, smokeless tobacco, and cigar use.
