Call for Presentations for SAMHSA's Prevention Day 2025

The Substance Abuse and Mental Health Services Administration (SAMHSA) opened calls for presentations at <u>SAMHSA's Prevention Day 2025</u> taking place on February 3, 2025, at Gaylord National Resort & Convention Center in National Harbor, Maryland. The theme for SAMHSA's Prevention Day 2025 is: "Telling the Prevention Story." To celebrate Prevention Day 2025, SAMHSA is seeking presentations for the conference that will share successes, challenges, and lessons learned from personal experience with substance use prevention strategy, policy, program, or research. Interested applicants must submit an abstract that addresses one of the following aims and tracks:

- Event Aims
 - Preventing initiation of substance use
 - Preventing progression of substance use
 - Preventing harms associated with substance use
- Event Tracks
 - Youth-led Prevention
 - Prevention Science, Public Health Research, and Evaluation
 - Innovative Prevention Strategies

SAMHSA's 7 Generations AI/AN Behavioral Health Center of Excellence Training and Technical Assistance Survey

The Substance Abuse and Mental Health Services Administration (SAMHSA)-funded <u>7</u> <u>Generations American Indian and Alaska Native (AI/AN) Behavioral Health Center of</u> <u>Excellence (CoE)</u> recently released the <u>7 Generations AI/AN Behavioral Health CoE</u> <u>Training and Technical Assistance Survey</u>. The survey is designed to assist the Center in developing culturally appropriate training curricula and technical assistance for mental health and substance use disorder (SUD) providers and paraprofessionals serving AI/AN communities. The short survey takes approximately 10 minutes to complete.

Responses are due by July 31.

PCSS-MAUD Microlearning Mini Video Series: FDA-Approved Medications for AUD

The <u>Providers Clinical Support System - Medications for</u> <u>Alcohol Use Disorder (PCSS-MAUD)</u> announced the release of a microlearning mini video series on <u>Food</u> <u>and Drug Administration (FDA)-Approved Medications</u> for Alcohol Use Disorder. This three-part video series

is designed for health providers to learn about FDA-approved MAUD, including Acamprosate, Disulfiram, and Naltrexone, with each episode lasting less than 8 minutes. Each episode provides a comprehensive overview of the medications and evidence-based tips for integrating these medications into clinical practices to improve care for individuals with AUD.

NIDA Study Examines Reasons Behind Physician's Reluctance to Intervene to Treat SUD

The National Institute on Drug Abuse (NIDA) recently published a new study in JAMA Network Open on <u>Physician Reluctance to</u> <u>Intervene in Addiction: A Systematic Review</u> that examined the reasons physicians give for not addressing substance use disorder

(SUD) in their clinical practice. The systematic review of 238 articles from 1960 to 2021 found that the most commonly reported reason for physicians not intervening to treat SUD was a lack of institutional support. Key findings from the study include:

- The most commonly cited reasons for physicians not intervening in SUD were: institutional environment (81.2% of articles), lack of skill (73.9%), cognitive capacity (73.5%), and knowledge (71.9%).
- Lesser cited reasons were negative social influences or beliefs about public and community acceptance of addiction care (~66%) and fear of harming the patient-physician relationship (~56%).
- Reimbursement concerns were also noted.

Further, the study revealed associations between these reasons and physician specialty, intervention type, and drug.

The authors note that the findings identify a need for institutional and societal changes to improve access to evidence-based treatment for physicians to treat people with SUD.

PCSS-MOUD & ORN Webinar: Addressing Disparities: Equitable Prescribing of Medications for Opioid Use Disorder in Black Populations
