

NASADAD Releases Updated Thematic State Opioid Response (SOR) Grant Briefs

Building upon the information NASADAD recently published on how each State is using State Opioid Response (SOR) grant funding to expand and enhance services across the continuum of care, NASADAD developed thematic briefs that identify common strategies States have used to implement programs and services in specific areas. Three briefs were developed on: State Harm Reduction Initiatives to Address the Opioid Crisis, State Efforts to Reach and Serve American Indians and Alaska Natives with Opioid and Stimulant Use Problems, and State Initiatives for People with Stimulant Use Problems. The briefs were developed with funding from the Substance Abuse and Mental Health Services

Advancing Smoking Cessation: FDA and NIH Priorities on October 21, from 9:00 am ET-4:30 pm ET, at the White Oak Campus in Silver Spring, Maryland. The event will also be livestreamed, here. The meeting will focus on advancing innovation of smoking cessation products for both youth and adults. Specifically, the meeting will feature presentations and panel discussions on the following smoking cessation-related topics:

- Clinical and community perspectives
- Promising target areas for development
- Regulatory paths forward

PCSS-MAUD Online Module: Alcohol Use Disorder and Common Co-occurring Psychiatric Conditions

The Substance Abuse and Mental Health Services Administration (SAMHSA)-funded Providers Clinical Support System – Medications for Alcohol Use Disorder (MAUD) released an online training module on Alcohol Use Disorder and Common Co-occurring Psychiatric Conditions. This two-hour on-demand training module is designed for clinical healthcare professionals who prescribe medications in outpatient or inpatient settings and

explores the interplay of alcohol use disorder (AUD) and common co-occurring psychiatric conditions, including bipolar disorder, major depressive disorder, and generalized anxiety disorder. Specifically, the module outlines how these conditions interact, diagnostic tools for screening and diagnosis, and treatment strategies. Learning objectives include:

- "Describe the complex interplay between alcohol use disorder and common psychiatric conditions.
- Identify key screening tools and diagnostic criteria for co-occurring conditions.
- Explore integrated treatment plans that incorporate behavioral and pharmacological approaches.
- Evaluate the impact of stigma, socioeconomic, and cultural barriers on treatment engagement and adherence.
- Synthesize knowledge from patient cases and healthcare professional insights to improve clinical practice."

Continuing Education (CE) credits are available upon completion of the module.

GAO Report: Behavioral Health: Information on Cost-Sharing in Medicare and Medicare Advantage

The Government Accountability Office (GAO) recently issued a new report on <u>Behavioral Health: Information on Cost-Sharing in</u> <u>Medicare and Medicare Advantage</u>. The report outlines behavioral



health benefit availability under Medicare and Medicare Advantage programs, including the out-of-pocket costs paid by beneficiaries and oversight by the Centers for Medicare & Medicaid Services (CMS) of cost-sharing in Medicare and Medicare Advantage plans for mental health and substance use disorder (SUD) services. Further, the report compares coverage under Medicare and Medicare Advantage programs across both inpatient and outpatient mental health and SUD services. A summary of key findings can be found here.
