NASADAD Releases Updated Brief on the Role of State Alcohol and Drug Agencies

NASADAD announces release of an updated brief that reviews the important role of State alcohol and drug agencies play in managing the publicly funded prevention, treatment, and recovery system. The brief notes that these agencies operate under different State statutes and regulations and vary in size, along with agency placement within government. Despite these differences, they share important common characteristics and play a central role in administering comprehensive substance use disorder services. Examples of core functions of State alcohol and drug agencies include:

- Managing the Substance Use Prevention, Treatment, Recovery Services (SUPTRS) Block Grant and opioid-specific grants such as the State Opioid Response (SOR) Grant
- Promoting effectiveness through planning, oversight, and accountability
- Data reporting
- Promoting and ensuring quality
- Encouraging collaboration across State government

- Working with the provider community

Around the Agencies

SAMHSA, ACF, & CMS Dear Colleague Letter: Keeping Families Together with Expanded Access to Medications for Opioid Use Disorder

The Substance Abuse and Mental Health Services Administration (SAMHSA), Administration for Children and Families (ACF), and the Centers for Medicare and Medicaid Services issued a Dear Colleague letter encouraging states, tribes, territories, and local partners to take immediate steps to ensure people with opioid use disorder can access medications for opioid use disorder (MOUD) without delay. This letter follows the ACF's recent designation of MOUDs as "well-supported" in the Title IV-E Prevention Services Clearinghouse, thus making them eligible for inclusion in state Title IV-E prevention plans. With this funding, states and tribes are now eligible for a 50% federal match to provide buprenorphine, methadone, and naltrexone to parents when children are at imminent risk of entering foster care but can safely remain at home or in kinship care with access to these treatments. The agencies seek to close treatment gaps and strengthen long-term family well-being by aligning child welfare, Medicaid, mental health, and substance use disorder systems.

ACF Press Release: Expanding Access to Medications for Opioid Use Disorder for At-Risk Families

This week, the United States Department of Health and Human Services' Administration for Children and Families (ACF) released a press release titled *ACF Expands Access to Medications for Opioid Use Disorder for At-Risk Families*. The ACF announced that three FDA-approved medications for opioid use disorder are now eligible for funding as prevention services under Title IV-E, which supports children and families in the child welfare system. States and tribes are now eligible for a 50% federal match to provide buprenorphine, methadone, and naltrexone to parents when children are at imminent risk of entering foster care but can safely remain at home or in kinship care with access to these treatments. Interested states, tribes, and territories may obtain sample program language and requirements from the ACF's Children's Bureau. Technical assistance is also available through the National Child Welfare Center on Innovation and Advancement and the National Center on Substance Abuse and Child Welfare.

HRSA: 2025 Year in Review

The Health Resources & Services Administration (HRSA) published its *2025 Year in Review*. The HRSA has worked to advance its mission to improve health outcomes to strengthen access to care nationwide. Some metrics of note include the following:



- HRSA-supported health centers served 32.4 million patients, including 1.1 million new patients, expanded telehealth to 17.6 million virtual visits, and provided preventive screenings to more than 10 million people.
- The Ryan White HIV/AIDS Program provided health care and support to nearly 602,000 people. Patients in the program achieved a 91.4% viral suppression rate.
- Rural health programs served 522,750 people, added 425 new mental health and substance use service providers, and created 60 new accredited rural residency programs since 2019. Naloxone was distributed at about 95% of Rural Communities Opioid Response Program sites.

HRSA Funding Opportunity: NHSC Loan Repayment Programs

The Health Resources and Services Administration's (HRSA) National Health Service Corps (NHSC) is now accepting applications for three loan repayment programs: [NHSC Loan Repayment Program](#), [NHSC Substance Use Disorder Workforce Loan Repayment Program](#), and [NHSC Rural Community Loan Repayment Program](#). These programs are designed to provide primary care, dental, and mental and behavioral health providers working at NHSC-approved sites with funding to be used toward their student loan debt. To be eligible, applicants must:

- "Be a U.S. citizen or national.
- Have a license to practice in the discipline and state you are applying to serve.
- Be a provider (or eligible to participate as a provider) in the Medicare, Medicaid, and the State Children's Health Insurance Program, as appropriate.
- Have qualifying student loan debt.

- Work at an NHSC-approved site.”

Applications are due March 31 at 7:30 p.m. ET. Eligible individuals may receive up to \$100,000 to pay off their student loans.

NIDA Director's Blog: All of Us Research Program "Unlocking Insights" Challenge Winners

In June, the National Institute on Drug Abuse (NIDA) launched the [“Unlocking Insights: Analyzing All of Us Data for Drug Addiction Research” Challenge](#). This data-science competition encourages innovative use of the [All of Us Research Program’s](#) extensive database, which includes electronic health records, surveys, biospecimens, wearable data, genomic information, and physical measurements, to advance understanding of substance use and addiction. Participating teams from universities, companies, and nonprofits were asked to identify and analyze correlations among genetic, environmental, developmental, and behavioral factors that influence addiction risk, resilience, treatment outcomes, or other aspects of substance use disorders. The challenge seeks to accelerate insights that can inform prevention, intervention, and policy.
