**How states are using State Targeted Response (STR) and State Opioid Response (SOR) funds to make a difference**


**PREVENTION INITIATIVES**

In April of 2019, the National Association of State Alcohol and Drug Abuse Directors (NASADAD) sent an inquiry to the Single State Agencies for alcohol and other drug services requesting information on how they were using the State Targeted Response (STR) and State Opioid Response (SOR) grants to address the opioid crisis in their states. The results of the inquiry were summarized into state-specific profiles highlighting prevention, treatment, overdose reversal, and recovery support efforts. State profiles generally covered a reporting timeframe between May 2017 - April 2019. A total of 50 state responses were received. Washington D.C. and U.S. Territories did not respond to the inquiry. Below is a brief analysis of the most common ways states have used STR/SOR funds for primary prevention initiatives, as well as select examples of innovative prevention initiatives.

### Around the Agencies

#### NIDA director publishes article on COVID-19 and implications for substance use disorders

Dr. Nora Volkow, Director of the National Institute on Drug Abuse (NIDA), published a piece in the *Annals of Internal Medicine* titled, "[Collision of the COVID-19 and Addiction Epidemics](#)." Dr. Volkow discusses how the serious health risks of

COVID-19 create challenges for people who smoke or vape, struggle with a substance use disorder (SUD), or are in recovery from addiction. For example, people with compromised lung conditions, including those who smoke, vape, or use opioids and methamphetamines, are at a heightened risk for complications from COVID-19. Additionally, social distancing will also decrease the likelihood of observed overdoses and the administration of naloxone may be less likely to occur, potentially resulting in more fatalities. Finally, physical distancing measures


may have a negative effect on people in recovery, as they are unable to obtain the important element of social support needed to sustain recovery. Dr. Volkow also notes the importance of efforts to deploy virtual support meetings and the possibility of take-home medications for individuals on medication-assisted treatment (MAT).

### **SAMHSA accepting applications for the Treatment, Recovery, and Workforce Support grant**

The Substance Abuse and Mental Health Services Administration (SAMHSA) is now accepting applications for the fiscal year (FY) 2020 [Treatment, Recovery, and Workforce Support grants](#). The purpose of the program is to implement evidence-based programs to support individuals in substance use disorder treatment and recovery to live independently and participate in the workforce. Eligible applicants include entities that provide treatment or recovery services for individuals with SUD and partner with one or more local or State stakeholders that support independent living and participation in the workforce. Recipients must also coordinate with the Single State Agency responsible for carrying out SUD prevention and treatment programs. SAMHSA plans to issue 8 grants of up to \$500,000 per year for up to 5 years and applications are due June 1, 2020.

### **FDA and Scholastic announce virtual youth e-cigarette prevention materials**

The Food and Drug Administration (FDA) and Scholastic are continuing to develop youth e-cigarette prevention education materials during the COVID-19 pandemic. All materials, intended for middle and high school students, are available online for free on "[The Real Cost of Vaping](#)" website and are configured for virtual learning. With youth out of school, the lessons include activities that involve statistics, reading comprehension, writing, presenting, and media literacy in conjunction with e-cigarette prevention. New resources, including two lessons, worksheets, and five short videos are now available on the site along with a guide for parents to talk to kids about e-cigarettes, infographics, and youth cessation resources.



### **SAMHSA publishes list of COVID-19 training and technical assistance resources**

The Substance Abuse and Mental Health Services Administration (SAMHSA) published a list of available training and technical assistance resources for the mental health and substance use disorder (SUD) fields as they navigate COVID-19. The list includes written resources, recorded webinars, and online trainings, from the Mental Health Technology Transfer Center Network (MHTTC), Addiction Technology Transfer Center (ATTC) Network, Prevention Technology Transfer Center (PTTC) Network, Serious Mental Illness (SMI) Adviser, Center of Excellence for Protected Health Information (CoE-PHI), Providers Clinical Support System (PCSS), and the Opioid Response Network (ORN). ### **In the News**

#### **LAPPA publishes model law on use of Overdose Detection Mapping Application Program**

The Legislative Analysis and Public Policy Association (LAPPA) recently published their first model law and accompanying analytic confidentiality document. As described in the announcement, the Model Act, titled "[Model Overdose Mapping and Response Act](#)", pertains to the use of the Overdose Detection Mapping Application Program (ODMAP) developed by the Washington/Baltimore High Intensity Drug Trafficking Areas (HIDTA). The ODMAP provides near real-time information about confirmed and suspected overdose incidents occurring in the United States and the Act is designed for the development of statewide legislation addressing overdose incident reporting. The [analytic confidentiality document](#) examines the extent to which the use of ODMAP implicates the protections for health information contained in the Privacy Rule of the Health Insurance Portability and Accountability Act of 1996 (HIPAA).
