- **Collaborative Hubs”**
 - Build provider/agency capacity to treat Opioid Use Disorders
 - Teams provide direct education and ongoing support



NEW MEXICO SOR KEY ACTIVITIES

- **Prevention:** The PAX Good Behavior Game (including versions tailored for indigenous communities)
- **Harm Reduction:** Naloxone awareness, training and distribution statewide. Includes tailored outreach for law enforcement and first responders; youth in detention; and tribal communities.

NARCAN AND OVERDOSE PREVENTION



- OD Prevention Training and Narcan Distribution
 - hubs established in 63.6% of counties
- Justice Involved Training
 - over 110 Law Enforcement Agencies
 - OD prevention training and Narcan have been provided to 89.3% of adult detention centers
- **988 Dispatched Mobile Crisis Teams will carry Narcan and Fentanyl Test Strips**

SOR TREATMENT

- MAT Expansion
 - **414** providers trained; support to **6 agencies** for OTP/RTC startup & accreditation
 - **19,512** trained in EBPs:
 - MI; ASAM; CRAFT
 - Expanded to 8 hospitals and 32 clinics
 - DOC Multisite program starting this Autumn
- Expanded Access to care:
 - **Over 3,000** Treated for OUD
 - Methadone: 1,165 people
 - Buprenorphine: 906 people
 - Naltrexone: 173 people

RECOVERY ACTIVITIES

- Peer Support, community recovery groups and celebrations, Choice Recovery Path programming and upcoming Recovery Capital program.
 - 10,697 have received recovery services through NM SOR
- Efforts include:
 - Expansion of peer placement in Emergency Departments, and use of virtual peer program
 - Expansion of Certified Peer Support Worker (CPSW) CE on OUD: 1438 people trained

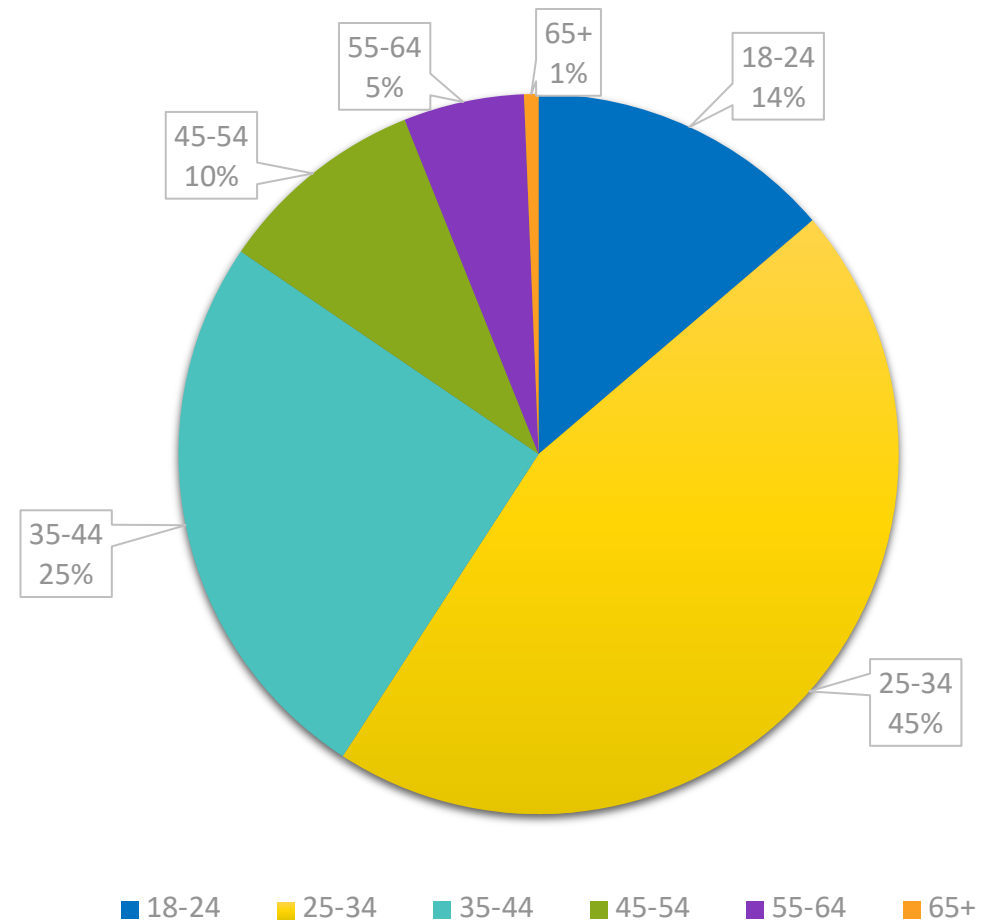
DEMOGRAPHICS OF CLIENTS/PATIENTS RECEIVING SERVICES UNDER NM SOR GRANT

Most clients/patients receiving treatment and recovery services are male (64%), identify as Hispanic or Latino (71%), and white (86%).

- **Gender:** 64% identify as Male, 36% identify as Female, 0.2% identify as Transgender
- **Ethnicity:** 71% identify as Hispanic or Latino
- **Race:**
 - 86% White
 - 9% American Indian
 - 4% Black or African American
 - 1% Native Hawaiian or Pacific Islander
 - 0.02% Asian
 - 0.03% Alaska Native

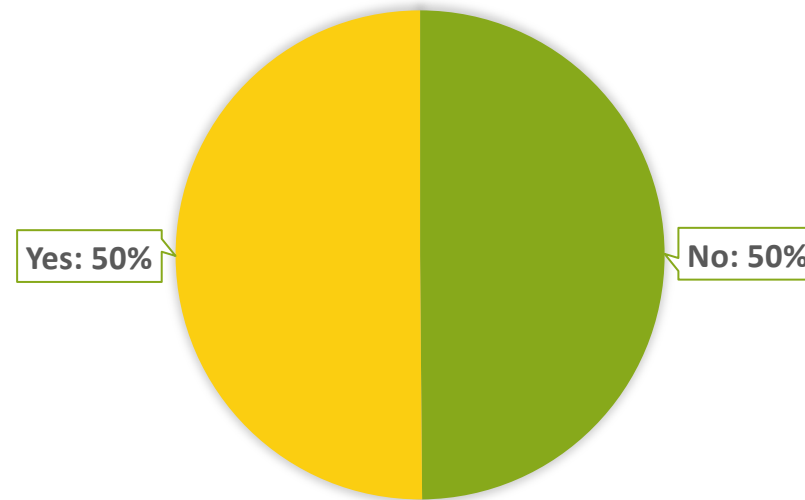
DEMOGRAPHICS OF CLIENTS/PATIENTS RECEIVING SERVICES UNDER NM SOR GRANT

- **Age:** Most clients/patients receiving treatment and recovery services are between 25- 34 years.
- 25% of clients/patients are between 35-44 years
- 14% are younger persons, between 18-24 years.

“HAVE YOU EVER EXPERIENCED VIOLENCE OR TRAUMA IN ANY SETTING?”

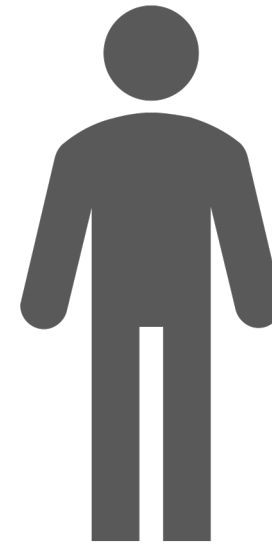
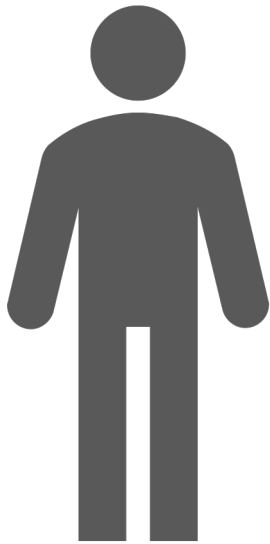


New Mexico has a long history of expanding trauma informed care services; SOR 3 (Oct 2022) will further build workforce capacity to provide care that is trauma informed.

N=756

LONGITUDINAL OUTCOMES: INJECTION DRUG USE

“In the past 30 days have you injected drugs?”



1 out of 3 clients are no longer injecting drugs at 6 month follow-up

N=153

LONGITUDINAL OUTCOMES: DEPRESSIVE SYMPTOMS

“How many days out of the last 30 have you felt depressed?”



40% of respondents reported fewer days experiencing depressed mood at 6 month follow-up

N=116

LONGITUDINAL OUTCOMES: ANXIETY

“How many days out of the last 30 have you felt anxiety?”



42% of respondents reported fewer days experiencing anxiety at the 6 month follow-up

N=129

LONGITUDINAL OUTCOMES: SOCIAL CONNECTEDNESS

“How satisfied are you with your personal relationships?”



Out of 106 people who responded, 31 reported feeling dissatisfied with personal relationships at baseline

Of the 31 reporting dissatisfaction at baseline, **45% reported feeling satisfied at 6 month follow-up**
