Capitol Hill Happenings

Bipartisan Group of Senators Introduce Bill Designed to Help Veterans Access Mental Health and SUD Treatment

A bipartisan group of senators introduced the <u>REMOVE Copays Act</u> last week, a bill designed to boost veterans' access to mental health and substance use disorder (SUD) treatment. Senators Kevin Cramer (R-ND) and Jon Ossoff (D-GA) introduced the bill, which aims to cut out-of-pocket expenses for veterans in need of mental health or SUD treatment at the Department of Veterans Affairs (VA). Instead of paying out-of-pocket, the Act would enable veterans to obtain copay-free mental health and SUD care through the VA and related community providers for their first three outpatient visits every year. The Act aims to give back to veterans by ensuring they have access to care and helping them adjust to civilian life to improve their physical and mental wellbeing.

Bipartisan Group of Representatives Urge House Leaders to Prioritize Fentanyl Scheduling Legislation

Last week, a bipartisan group of representatives sent a letter to House leaders Speaker Nancy Pelosi (D-CA-12) and Minority Leader Kevin McCarthy (R-CA-23) urging them to call for a vote on the <u>Save Americans from the Fentanyl Emergency (SAFE) Act of 2022 (H.R. 6946)</u> and the <u>Dark Web Interdiction Act of 2022 (H.R. 7300)</u> before the deadline for temporary scheduling on December 31, 2022. Representatives Chris Pappas (D-NH-1), Ted Budd (R-NC-13), and Tony Gonzales (R-TX-23) sent the letter in response to annual overdose deaths in the United States reaching over 100,000 in 2021. The group called on leaders to pass this legislation to ensure law enforcement has the means to combat drug trafficking, remove deadly substances, and keep communities safe, especially those who suffer from substance use disorder (SUD). Specifically, Pappas' two bills will:

- "The SAFE Act of 2022 will amend the Controlled Substances Act to permanently classify fentanyl-related substances that are not already exempted as a Schedule I drug, require that the Attorney General publish a list of fentanyl-related substances, allow the Department of Health and Human Services to conduct research on fentanyl-related substances, and require that the Government Accountability Office publish a report on the effects of permanently scheduling fentanyl-related substances as Schedule I.
- The Dark Web Interdiction Act would direct the Sentencing Commission to increase penalties for trafficking illegal drugs through the dark web, make the Joint Criminal Opioid and Darknet Enforcement (J-CODE) task force permanent, and require that the Department of Justice, the Department of Homeland Security, and the Department of Treasury publish a report on the use of virtual currency for opioid trafficking."

HRSA Funding Opportunity: Primary Care Training and Enhancement - Residency Training in Mental Health and SUD



The Health Resources and Services Administration's (HRSA) Bureau of Health Workforce announced a <u>funding opportunity</u> to train primary care residents in the prevention, identification, diagnosis, treatment, and referral of services for mental health and substance use disorder (SUD) in at-risk populations. The funding must be used to support didactic training and at least a one-month clinical rotation focused on mental health and SUD, although longer rotations are encouraged. The application deadline is Tuesday, November 15, 2022, with an estimated total program funding of \$60 million for up to 23 recipients over 5 years. Eligible entities include:

- "Accredited public or nonprofit private hospitals;
- Schools of allopathic medicine or osteopathic medicine;
- Residency programs accredited by the Accreditation Council for Graduate Medical Education in family medicine, general internal medicine, general pediatrics or combined internal medicine and pediatrics ("med-peds"); and
- Tribes and tribal organizations, if otherwise eligible."

HRSA will host a <u>technical assistance webinar</u> at 3:30 pm (ET) on October 18, 2022, with more information about this funding opportunity, including application requirements.

SAMHSA Awards \$45.1 Million to Help Meet Health Needs of People At Risk for or Living with HIV/AIDS

The Substance Abuse and Mental Health Services Administration (SAMHSA) recently awarded \$45.1 million in grants to meet the health needs of people at risk of, or already living with, HIV/AIDS. These grants aim to decrease HIV/AIDS transmission among those with mental health or substance use disorder (SUD), link HIV care to people with cooccurring mental health and SUD, and facilitate access to treatment and recovery services. The \$45.1 million comprises the:

- "Minority AIDS Initiative: Substance Use Disorder Treatment for Racial/Ethnic
 Minority Populations at High Risk for HIV/AIDS This grant program works to
 increase engagement in care for racially and ethnically underrepresented
 individuals who have substance use disorders (SUD) and/or co-occurring substance
 use and mental health disorders (COD) who also are at risk of contracting or who
 are living with HIV/AIDS and receive HIV/AIDS services or treatment: \$30.4
 million.
- Substance Abuse and HIV Prevention Navigator Program for Racial/Ethnic
 <u>Minorities Cooperative Agreement</u> This grant program seeks to provide substance
 misuse and HIV prevention services to racial or ethnic minority males at risk for
 HIV/AIDS. The program places an emphasis on males who have sex with other
 males, including transgender individuals, as well as those who identify as LGBTQ+
 who are not in stable housing and reside in communities with high incidence rates
 of HIV: \$5.5 million.
- Minority AIDS Initiative Service Integration The purpose of this program is to
 provide resources to help reduce the co-occurring epidemics of HIV, hepatitis, and
 mental health disorders through accessible, evidence-based, culturally
 appropriate mental and co-occurring disorder treatment that is integrated with

HIV primary care and prevention services: \$9.2 million."

This funding supports harm reduction efforts, in line with the <u>Department of Health and Human Services' (HHS) Overdose Prevention Strategy</u>, by aiming to reduce the harms of drug use that increase the risk of infectious diseases, namely HIV, viral hepatitis, and bacterial and fungal infections. NIH HEAL Initiative Releases JCOIN e-Course: SUSTAIN Substance Use Disorders

The National Institutes of Health's (NIH) Helping to End

Addiction Long-term (HEAL) Initiative recently released an e-Course on the Justice

Community Opioid Innovation Network's (JCOIN) Coordination and Translation Center

concerning Staff Undertaking Skills to Advance Innovation (SUSTAIN) in substance use

disorder (SUD) services in the criminal justice system. The course is designed to help

justice system professionals, who routinely interact with people experiencing SUD and

co-occurring disorders (COD), connect patients/clients with evidence-based treatment.

To create coordinated criminal justice and SUD partnerships and improve patient

outcomes, this e-course provides foundational knowledge on SUD and COD, reviews

evidence-based practices for addressing them, and offers practical information and

resources to improve treatment access and delivery. The course's goals are to:

- "Gain appreciation for why understanding SUD and COD is important for justicesystem professionals
- Increase knowledge about SUD and COD
- Develop knowledge and appreciation of evidenced-informed practices that can facilitate behavior change processes
- Gain exposure to evidence-based practices of coordinated criminal justice and behavioral health responses to addressing SUD and COD in justice-involved populations
- Provide links to resources for working with justice-involved individuals who may experience SUD and COD."

The course provides a certificate for completion and takes approximately 1.5 hours.

SAMHSA's GAINS Center Now Accepting Applications for Sequential Intercept Model (SIM) Mapping Workshops



The Substance Abuse and Mental Health Services Administration's (SAMHSA) <u>Gather</u>, <u>Assess</u>, <u>Integrate</u>, <u>Network</u>, <u>and Stimulate</u> (<u>GAINS</u>) <u>Center</u> is seeking <u>applicants</u> for <u>Sequential Intercept Model (SMI) Mapping Workshops</u>. The Workshops strive to bring together a local, multidisciplinary group of stakeholders from a particular jurisdiction to facilitate collaboration and identify ways the barriers between the criminal justice and mental health and substance use disorder (SUD) systems can be reduced with integrated local strategic action plans. The GAINS Center will provide these SIM Mapping Workshops free of charge to select applicants between March and August 2023 and plans to conduct them in person. The GAINS Center is accepting applications for two SIM Workshops:

- "Traditional SIM Mapping Workshops: The GAINS Center is soliciting applications
 from communities that are interested in "traditional" SIM Mapping Workshops that
 focus broadly on identifying and responding to the needs of adults with mental
 and substance use disorders who are involved or at risk for involvement in the
 criminal justice system.
- SIM Mapping Workshops to Develop Comprehensive, Community-Wide Strategic Plans for Addressing Opioid and Other Substance Use: The GAINS Center is also soliciting applications from communities that are particularly interested in developing comprehensive, community-wide strategic plans for addressing opioid and other substance use, and better identifying and responding to the needs of adults with substance use disorders who are involved or at risk for involvement in the criminal justice system. Applications submitted in response to this solicitation should emphasize resources, gaps and opportunities, as well as commitment among key stakeholders to addressing these issues."

Interested applicants should select the one workshop option that is most relevant or of greatest interest and submit a completed application form no later than November 10, 2022. SAMHSA's GAINS Center will hold no-cost webinars on October 19, 2022, at 2:00 pm (ET) and October 20, 2022, at 3:00 pm (ET) on additional details on the opportunity and application submissions. Both webinars require registration.
